



The 105th Running Of The TWINSPIRES.COM LOUISIANA DERBY EARLY BIRD \$1,000,000 Guaranteed (Grade II)

FOR THREE YEAR OLDS (Foals of 2015) Early Bird Nomination Fee of \$400 due by Saturday, December 23, 2017, which includes nomination fee for The Lecomte Stakes (GIII) and The Risen Star Stakes (GI) (Early Bird). Final nomination for The Louisiana Derby closes Saturday, March 10, 2017 by subscription of \$1,000. \$5,000 to enter, \$5,000 additional to start. Supplemental nominations of \$25,000 will be accepted at time of entry which shall include all fees. \$1,000,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weights: Colts and Geldings - 122 lbs; Fillies - 117 lbs. Starters to be named through the entry box by the usual time of closing. The Louisiana Derby will be limited to fourteen (14) starters. Preference will be given in the following manner: First preference to graded or group winners in order (I,II,III), then to horses that have accumulated the highest lifetime earnings. Any horse excluded from running because of the aforementioned preference will be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Certain finishing positions in this race will earn points to qualify for the 2018 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. Points will be earned in the following manner: 100 to the winner, 40 to second, 20 to third and 10 to fourth.
